- (a) Continuation/ extension in provisional affiliation of existing courses with earlier sanctioned intake, i.e., B. Tech. in CSE (120 seats), ECE (120 seats), ME (60 seats), BBA (120 seats) and MBA (60 seats) for/from the session 2012-13.
- (b) Provisional affiliation for introduction of B. Tech. in Civil Engg. (60 seats) subject to the establishment of "elements of Civil Engg. lab" before the start of the session as per new scheme and syllabus for the 1st year approved by DCRUST from the session 2012-13.
- (c) Provisional affiliation for introduction of M. Tech. CSE (24) for / from the session 2012-13 subject to the procurement of Rational Rose Software and appointment of relevant faculty through duly constituted selection committee.
- (d) Provisional affiliation for introduction of M. Tech. ECE (24) for / from the session 2012-13 subject to the establishment of Digital VLSI design lab, Advoptical Engg. lab, advanced image processing lab & Adv. Microprocessor & Adv. Microcontrollers lab and also appointment of qualified faculty as per AICTE norms through duly constituted selection committee.
- (e) (i) Closure of existing B. Tech. course, i.e., Information Technology (60 seats) at 1st year level from the session 2012-13. (ii) Continuation / Extension in provisional affiliation in 2nd year, 3rd year and 4th year for / from the session 2012-13.

The continuation/extension in provisional of existing courses and provisional affiliation for introduction of new UG/PG courses for / from the session 2012-13 as explained above, are subject to the condition that the institute shall make full compliance of the observations made in the inspection report dated 11-7-12 within one month under intimation to the University. The above provisional affiliations are further subject to the condition that the institute will make full compliance of the provisions laid down in the Statute, Ordinance and the decisions taken by this University from time to time. A copy of the inspection report dated 11-07-12 of the inspection committee is enclosed herewith for immediate necessary compliance.

Further, it is made clear to the college that in the event of non compliance / fulfillment of the prescribed conditions / requirements, the University shall have the right to withdraw / refuse the provisional affiliation to the institute in the next academic session and all responsibilities arising due to such refusal / withdrawal would solely be that of the said institute
