

It is intimated that a re-inspection committee, constituted by this University, inspected your institute on 13.07.2013 to verify the compliance of previous conditions of affiliation and availability of requisite faculty, staff and infrastructural facilities of existing courses, i.e., B. Tech. in CE (60 seats), CSE (120 seats), ECE (120 seats), ME (60 seats) and M. Tech. in CSE (24 seats), M. Tech. in ECE (24 seats) and BBA (120 seats) and MBA (60 seats) and regarding grant of provisional affiliation for the introduction of two new PG courses, i.e., M. Tech. in CSE (Part Time) 24 seats and M. Tech. in ECE (Part Time) 24 seats for the session 2013-14 and has submitted the report.

The Vice-Chancellor, after considering the report, has been pleased to grant extension / continuation in provisional affiliation for existing courses, i.e., B. Tech. in CE (60 seats), CSE (120 seats), ECE (120 seats), ME (60 seats) and M. Tech. in CSE (24 seats), M. Tech. in ECE (24 seats) and BBA (120 seats) and MBA (60 seats) and provisional affiliation for the introduction of new PG course M. Tech. in ECE (Part Time) 24 seats for the session 2013-14. However, the affiliation for M. Tech. in CSE (Part Time) 24 seats has not been granted for the session 2013-14.

The extension / continuation in provisional affiliation for the said existing courses and introduction of new PG course M. Tech. in ECE (Part Time) 24 seats for the session 2013-14 is subject to the condition that your institute will rigorously make full compliance of the observations / deficiencies pointed out in the report by the inspection committee. The compliance of the same alongwith supporting documents (such as bills of materials / items procured, selection committee proceedings, joining reports, photographs of facilities created, faculty, staff etc.), be submitted to this university at the earliest but not later than one month from the issue of this letter.
