The Vice-Chancellor, after considering the report, has been pleased to grant extension/continuation in provisional affiliation for the session 2015-16 for the existing courses as per details given below:-

- (B) PG Courses (Full Time):  
M. Tech. CSE (24 seats), M. Tech. ECE (24 seats), MBA (60 seats).
- (C) PG Course (Part Time):  
M. Tech. ECE (24 seats)

subject to the condition that the institute shall make full compliance of the observations made in the inspection report in the upcoming session 2016-17 under intimation to the University. A photocopy of the inspection report dated 31.8.15 is enclosed herewith for necessary compliance (alongwith all supporting documents / proofs such as bills of materials / items procured, photographs / maps of facilities created, etc.). The compliance report be submitted within one month.

The above provisional affiliation for the existing UG/PG courses with earlier sanctioned intake is further subject to the condition that the institute will make full compliance of the provisions laid down in the Statute, Ordinance and the decisions taken by this University from time to time.

Further, it is made clear that in the event of non compliance / fulfillment of the prescribed conditions / requirements, the University shall have the right to withdraw / refuse the provisional affiliation to the institute in the next academic session and all responsibilities arising due to such refusal / withdrawal would solely be that of the said institute / trust.
